Attached please find a registration form, an invoice, and a preliminary program for NACCA's 83<sup>rd</sup> Annual Meeting and Regulators' Training Symposium, to be held June 4-7, 2018, at the Turnberry Isle hotel.

Attached is a fill-in registration form and invoice that you can complete, print and then mail back to the NACCA office with your check. Or you may fax these forms with your credit card or EFT info to 614 326-1162.

Please take advantage of this opportunity to network with fellow regulators from other states and agencies, who are dealing with many of the same issues confronting you in the regulation of the consumer credit industry. Your attendance, along with your training, compliance, and legal staff, is strongly encouraged. Please note the following:

- Your completed registration form and registration fee must be returned to the NACCA office prior to May 11, 2018. **Register before May 7<sup>th</sup> and receive a \$100 discount, per person.**
- The NACCA program will begin on Tuesday, June 5 at 10:45 a.m. A preliminary program is attached.
- The meeting also includes a one-day educational and training program with the American Financial Services Association on Thursday, June 7. This program will provide a unique opportunity to discuss issues of common concern with members of the consumer finance industry.

- This year's Annual Meeting registration fee is \$695 per person (\$595 if you register early). This fee includes morning and afternoon refreshment breaks, Tuesday lunch, Wednesday's breakfast & President's luncheon, and Thursday's breakfast, lunch, and reception. The honorary, spouse and guest registration fee is \$225 per person (\$125 if you register early). Registered honoraries, spouses and guests may attend the President's Luncheon and the entire Thursday program.
- Again this year, we are offering an Early Bird Registration fee of \$595, a \$100 savings if your registration form and fee are received before May 7. Please see the attached registration form for more information on Early Bird discounts.
- A registration invoice is attached. Simply complete the "Agency Name and Address" box and indicate the number of persons registering and total amount of fees being paid, and forward it to your office's fiscal department. If needed, a personalized invoice can also be furnished to your agency upon request to the NACCA office.
- The dress attire for this year's meeting will be business casual for meetings and business casual or resort wear for receptions.
- To receive NACCA's group rate of \$119.00 per night (plus applicable taxes, currently 13%), you may make your reservation online at: <https://aws.passkey.com/go/NACCA2018> or by calling 1-866-612-7739 and requesting the NACCA 2018 group rate. You will be required to submit a credit card to guarantee your reservation. The hotel's deadline for room reservations is May 7, but our room block may sell out far in advance of this date.

***I suggest that you make your reservations early. After our room block is full, we cannot guarantee rooms or a \$119 government rate at this hotel.***

For those of you flying to the Annual Meeting, the hotel is located about 12 miles from the Fort Lauderdale International Airport (FLL) and 17 miles from the Miami International Airport (MIA). A MIA airport to hotel transportation option is the Shuttle Shuttle, a shared van service, charges \$52 per person roundtrip to transport you to our meeting hotel. The FLL airport to hotel transportation option is the GO Airport Shuttle, a shared van service, charges \$36 per person roundtrip (which includes tip). Reservations are highly recommended, but not required. Additional information on these shuttles will be sent to all meeting registrants in May.

If you arrive by car, hotel valet parking is \$37.45 daily. There is no hotel self -parking or nearby lots.

Taxi fare is approximately \$40 one way from the FLL airport to the hotel.
